# Money Laundering and Proceeds of Crime (Amendment of Schedule) Notice, 2019

Pursuant to section 112 of the Money Laundering and Proceeds of Crime Act, 2008<sup>1</sup>, I,

## MOEKETSI MAJORO

Minister of Finance, amend the List of Accountable Institutions by deleting Schedule 1<sup>2</sup> and substituting the following:

1.

## "Schedule 1 List of Accountable Institutions

- (a) a financial institution as defined under the Financial Institutions Act, 2012<sup>3</sup> and a financial service-provider which includes the following:
  - (i) a provider of mobile money services;
  - (ii) a person who provides money remittances services;
  - (iii) a collective investment scheme;
  - (iv) a pension fund;
  - (v) a co-operative society as defined under the Co-operati-

tives Societies Act, 20064;

- (vi) a person carrying out insurance business under the Insurance Act, 2014<sup>5</sup>; and
- (vii) a person licensed under the Capital Markets Regulations, 2014<sup>6</sup>.
- (b) a designated non-financial business and profession (DNFBP) which includes the following:
  - (i) a legal practitioner as defined under the Legal Practitioners Act, 1983<sup>7</sup>;
  - (ii) an accountant as defined under the Accountants Act of 19778;
  - (iii) a casino including internet and ship-based casino;
  - (iv) lottery;
  - (v) a real estate agent;
  - (vi) a dealer in precious metals;
  - (vii) a dealer in precious stones;
  - (viii) a trust and company service provider which include a person or business providing any of the following services to a third party:
    - (viiia) acting as a formation agent of a legal person;
    - (viiib) acting as or arranging for another person to act as a director or secretary of a company, a partner of a partnership, or a similar position in relation to other legal person;
    - (viiic) providing a registered office, business address

- or accommodation, correspondence or administrative address of a company, a partnership or any other legal person or arrangement;
- (viiid) acting as or arranging for another person to act as a trustee of an express trust or performing the equivalent function for another firm of legal arrangement; or
- (viiie) acting as or arranging for another person to act as a nominee shareholder for another person;
- (c) a designated business, when clients or customers engage in cash transactions equal to or above the threshold of M25, 000.00, which includes the following:
  - (i) a dealer in motor spare parts;
  - (ii) a hardware store;
  - (iii) a motor vehicle dealership;
  - (iv) a manufacture; and
  - (v) a wholesaler;
- (d) a non-profit organisation (NPO); and
- (e) any other person or institution who may be declared as such by the Minister by notice in the Gazette".

### Repeal

2. The Money Laundering and Proceeds of Crime (Amendment of Schedule) Notice, 2017<sup>9</sup> is repealed.
